Natalie Wright: Good Morning Everybody. This Natalie and this is the November 23rd Special Meeting of the Suffolk County Landbank Corporation Board of Directors, and for the record, we do have a quorum present. The Notice of the Meeting followed the Open Meetings Law and due to the ongoing pandemic, the meeting is being held virtually via Zoom. All votes on Board Actions and Resolutions will be done via roll call and we ask the Board Members clearly state their name when making a motion and clearly state their vote when their name is called. Natalie Wright: Great. Moving into the Public Portion. The Public Portion will now be open to individuals who submitted a request to speak to landbank@suffolkcountyny.gov. Mikael, do we have any public speakers for this meeting?

Mikael Kerr: We did not receive any public speakers.

Natalie Wright: Okay, great. So, now we will close the Public Portion. Moving into New Business, there is one item on the agenda. It is Resolution 2021-26, ACQUISITION OF COUNTY OWNED PROPERTY BY THE SUFFOLK COUNTY LANDBANK. Mikael or Sarah, do you want to give any background on this one.

Sarah Lansdale: So, Mike, do you want to provide an overview?

Mikael Kerr: Sure. The County Auction is coming up December 1st and there's two properties that the Landbank identified that we would like to purchase from the County. You know, as everyone may not be aware, Article 16, Section1616 of the Not-for-Profit Law, which governs Landbanks for New York State, gives landbanks the ability to tender a bid at a public auction in the amount of the judgment, and then essentially, the County is basically, not required, but should sell us the property pending legislative approval. So, we wanted to pass a resolution now, so that we have the ability to make that request. And, it's two properties:

The first one is this property up on the screen, 131 E. Booker Ave. in Wyandanch. It's in the 15^{th} Legislative District. Tax Deed was taken in 2017, and the County investment, which the Landbank would be paying to the County is \$76,620.00 \pm , plus there may be some additional holding costs in between now and the closing, so we're doing \pm just to reflect other potential costs.

The second property is 41 Magnolia St. in Central Islip. This is in the 10th District. This Tax Deed was taken in 2018 and has a County investment of \$100,667.72, and same thing, ± in case there is any additional costs that arise.

Sarah Lansdale: So Mike, we've done this before, correct, where we have purchased homes that were held by the County?

Mikael Kerr: Correct. We've done this a number of times now.

Sarah Lansdale: Okay, great. Then the second question would be, the purposes of this would be for to rehab under our Arbor Program, which is for first-time homebuyers, correct?

Mikael Kerr: Correct, yes, these would be typical Landbank properties where we partner with CDC or Long Island Housing Partnership, do the renovation and then sell them to first-time homebuyers. And, both of these properties are in our target areas, and we've done a number of rehabs in these specific neighborhoods where these properties are located.

Sarah Lansdale: And, the target areas are, just correct me if I'm wrong, those are areas that were

hardest hit by the foreclosure crisis?

Mikael Kerr: Correct, and still see low property values and high foreclosure rates to this day.

Sarah Lansdale: Okay, great. Any questions?

Natalie Wright: Seeing no questions, is there a motion for approval?

Hon. Rich Schaffer: Schaffer will make a motion.

Natalie Wright: Supervisor Schaffer with a motion. Is there a second?
